### Case Management Redesign (CMRD) Updates

Shari Repinski reported an update to the Board about Case Management Redesign updates including the complaint filed and data system issues. Governor Polis' JBC (Joint Budget Committee) approved a sum of money to stabilize operations. RMHS will receive \$6.2M or 23% of the \$27M allocated to the CMA transition based on initial RFP of total population served.
